You may request a fee waiver if your documented annual household income is at or below 150 percent of the Federal Poverty Guidelines (FPG) or if you can demonstrate financial hardship including, but not limited to, medical expenses of family members, unemployment, eviction, victimization, and homelessness.</p> <p>You can find the list of applications and petitions that are eligible for a fee waiver at <a href="http://www.uscis.gov/I-912">www.uscis.gov/I-912</a> or refer to 8 CFR 103.7(c)(3). For filing tips and additional information, see <a href="http://www.uscis.gov/I-912">www.uscis.gov/I-912</a>.</p> <p>To request a fee waiver, you must submit Form I-912 and provide the supporting documentation. A letter stating you are unable to pay the filing fees or biometric services fees will not be accepted without a completed Form I-912 and supporting documentation.</p> <p>You do not need to file Form I-912 for applications and petitions that do not require a filing fee. Some USCIS applications and petitions have fee exemption requirements for certain types of applicants and petitioners.
