






1 Pursuant to the plaintiffs' Motion for Voluntary
2 Dismissal of Action, the proposed form and method of giving
3 Rule 23(e) notice to the certified class is hereby approved.

4 On or before Dec. 31, 1993, the parties shall
5 consult and ensure that the notice in the English and Spanish
6 languages is appropriately posted for a period of thirty days
7 on each of the official Immigration Court bulletin boards in
8 the Los Angeles, San Pedro, San Diego, and El Centro
9 Immigration Courts.

10 Plaintiffs shall notice a hearing immediately subsequent
11 to the expiration of the thirty day period for purposes of
12 considering any timely objections to the Motion for Dismissal
13 and/or for purposes of dismissing this action.
