

ICE Milwaukee Update—03/16/2020 (COVID-19)

General ICE operations

- ICE operations continue and are still running in full force. They will continue to work as normal with some agents working remotely (tele-work).
- SDDO Brent Kriehn explained that they will reassess local ICE operations in Milwaukee “as we get a handle on CONVID-19 in terms of growth or shrinkage in Wisconsin.”

Management changes

- SDDO Cassandra Kubiszewski is in charge of Criminal Alien Program (CAP) Unit.
- SDDO Brent Kriehn is now in charge of the Fugitive Operations (FUG OPS) Unit.
- SDDO Craig Croninger is in charge of Non-Detained/Alternative to Detention (ATD).
- An updated directory/points of contact was sent to me today by SDDO Brent Kriehn and is attached to this email.

COVID-19

- ICE ATD agents are in the process of calling all the aliens with orders of supervision at the phone numbers they have on file. Please note that there was no mention that ATD agents are calling the attorneys of record.
- All orders of supervision appointments will be canceled through **April 17, 2020**. The earliest they will be rescheduled to will be early May 2020.
- For aliens eligible to be released on bonds, ICE Milwaukee has received authorization to release aliens directly from the detention facility once the obligors have paid the bonds at ICE Milwaukee. Once the bonds are posted, the obligors will be directed to pick up the aliens at the detention facility (i.e. Dodge County).
- Sitting arrangements have been changed at USCIS Milwaukee to comply with CDC guidelines in terms of social distancing.
