What Is the Filing Fee?</b>  The filing fee for Form I-589 is <b>\$50</b> . This fee may not be waived under 8 CFR 106.3.  There is no fee if you are in proceedings and file this form with the Immigration Court, or if you are filing with USCIS and are a UAC in removal proceedings before an immigration judge.  <b>NOTE:</b> The filing fee is not refundable, regardless of any action USCIS or the Immigration Court takes on this application. <b>DO NOT MAIL CASH.</b> You must submit all fees in the exact amounts.  <b>Payments by Check or Money Order</b>  Use the following guidelines when you prepare your check or money order for the Form I-589 filing fee:  <b>1.</b> The check or money order must be drawn on a bank or other financial institution located in the United States and must be payable in U.S. currency; <b>and</b>  <b>2.</b> Make the check or money order payable to <b>U.S. Department of Homeland Security</b> .  <b>NOTE:</b> Spell out U.S. Department of Homeland Security; do not use the initials “USDHS” or “DHS.”  <b>Notice to Those Making Payment by Check.</b> If you send us a check, USCIS will convert it into an electronic funds transfer (EFT). This means we will copy your check and use the account information on it to electronically debit your account for the amount of the check. The debit from your account will usually take 24 hours and your bank will show it on your regular account statement.

Your original Form I-589, with all questions completed, and the application signed by you in <b>Part D</b> and signed by any preparer in <b>Part E</b>; and</li> <li>2. One passport-style photograph of you stapled to the form at <b>Part D</b>.</li> </ol> <p>Behind your original Form I-589, attach in the following order:</p> <ol style="list-style-type: none"> <li>1. Incomplete Asylum Applications</b></p> <p>An asylum application that is incomplete will be returned to you by mail within 30 days of receipt of the application by USCIS. An application that has not been returned to you within 30 days of having been received by USCIS will be considered complete, and you will receive written acknowledgement of receipt from USCIS.</p> <p>The filing of a complete application starts the 150-day period you must wait before you may apply for employment authorization. If your application is not complete and is returned to you, the 150-day period will not begin until you resubmit a complete application. (See <b>Section V, Employment Authorization While Your Application Is Pending, Part 2</b> of these instructions for further information regarding eligibility for employment authorization.)</p> <p>An application will be considered incomplete in each of the following cases:</p> <p>1.
