Subject: Unfair Judgement Decision

I the undersigned is requesting a review of a case that has been unfairly judged, due to the prejudice that was exhibited by Judge William Cassidy of (b) (6) The case involves a mobile mechanic by the name of (b) (6) You see (b) (6) is a hard working individual who has lived in this country for at least 25 + years, He is not a drug dealer, murderer, rapist or has not had any felonious criminal activity, as an entrepreneur he ha also been a family man who has taking care of his 4 children by himself until he lost his home to foreclosure in 2006, he has had a rough life but has found ways to make it, He takes pride in home and his ability to be there for his children and always expect the best from them.

Especially on the fateful day in march, He came home from work and grocery shopping after a long day of getting emergency call for car breakdowns only to find that, his daughter who was spending a few days with us was responsible for the bad odor. So as he came home that day he had a argument with his daughter with daughter, regarding her not keeping the home clean since there was a bad odor coming from the home. In talking to her about the cleanliness of the home, He was a bit more upset than usual which would be normal with anyone. He did things which I had never seen him do that even upset me. I call the police because I did not want to escalate since she was with child. I requested him to get anger management help of which he agreed to. However part of the agreement was for him to take responsibility of his actions.

At his immigration hearing, Judge Cassidy implied that this man is lazy and mooching of of me. This a very far from the case That is where I feel prejudice has been exhibited. The year I met (b) (6)

(b) (6) I was attending college and employed. but lost my job due to schedule conflicts. Then also lost my car. (b) (6) took care of Me and my 2 sons. Where I was also struggling to keep my home from foreclosure. I am also occasionally unable to walk due to back injury from accidents and occasional sciatica disabling me. I am now back to work for 2 years now because he bought me a massage chair that helped me when my back locks up. It is not my intention to cause this kind of stress on his family Because I assist him to take care of them. He has always been obligated to his family when he has 1000.00 dollars or just \$1.00.

He moved from Florida in 2000 to get away from the problems and negativity he was experiencing with his wife, took his children and came to live with his mother to assist her since his father passed away and she is disabled. He is very well known as a kind and always willing mechanic, He has fixed many customers cars even when thy do not have money to pay. As difficult as it was for us. that is who he is. He is more of a model citizen who made a stupid mistake. He loves his children dearly and would never intentionally hurt them. Before he was arrested he would be the only to put (b) (6) (his gran-daughter) to sleep by dancing her around the room. He was also accused of not paying taxes but due to his limited income he has asked me most times to file and due to the amounts he made, most times I was told by turbo tax that he has not made enough money. In fact he had worked for many towing companies in the area of which taxes were deducted from his check the only problem was that he did not file for a refund. He struggled but made an honest living. He has been incarcerated since march 24th 2011 until now.

His hearing was on August 5th, we were told we would have a decision in 1 week by Judge Cassidy. Only to get a decision this week Thursday 11-03-2011. We have had to pay back customers monies for cars that were being fixed that were not completed. We had been struggling financially. I believe that since the case has been not judged fairly he should not be sent home to Jamaica. Because it will proven even more prejudice. He may have been in minor trouble in (b) (6) but take a look at his record in (b) (6) which has been over 10 years no issues. He is a an honest man not like Judge Cassidy has implied lazy, or it is not like every Jamaican that wears dreadlocks doing illegal activity. I certainly would not be with him. Please reconsider cancelling deportation on this case his boys need him desperately. He is a very skilled mechanic that likes to work on engines. Its not fair. By the way the case that got him in has not been able to conclude since immigration court would not release him for a hearing regarding his disorderly conduct. So I feel his rights have been very violated.
