or decision. This additional 30 days covers the time needed to: review your case, issue a decision, mail the decision, and allow for mailing time through the Post Office.

When can I call the National Customer Service Center?

If you do not receive any correspondence from the Service Center within the dates described below, you can call the National Customer Service Center toll free at 1-800-375-5283 for a case status referral. The referral will be sent to the Service Center where your petition or application is pending. That Service Center will then research your case and respond to you within 30 days.
