The undersigned organizations urge you not to add any extraneous provisions from H.R.10 to the Intelligence Reorganization legislation passed by the Senate. The Senate bill, S. 2845, passed in an overwhelming bipartisan vote. H.R. 10 barely survived a move on the House floor to substitute the Senate bill and contains many controversial provisions regarding surveillance, immigration, and other issues that violate privacy, civil liberties and human rights.

We also urge you to reconsider those provisions of the Senate bill that raise privacy concerns such as those that appear to be a precursor to a national ID. We do not believe that the Congress or the public has had an adequate opportunity to analyze the ramifications of these provisions on privacy and civil liberties.
