












Timeline



PROCESS TIMELINES

1

International Promotion section

Each seasonal labor agent received all the documents needed to start the recruitment process.

This stage of the process entails receiving all the documents on the same day they are sent by the employer

2

Recruitment section

Our recruitment team requests all this information from the National Employment Service

The National Employment Service have different offices across the country where the workers can go to register.

After identifying potential workers, the National Employment Service send a list with all the information

Our recruitment team serves as the final filter; they verify criminal records, health conditions and work experience.



The recruitment process can take about 4 weeks.

Orientation section

General aspects of the Program

We conduct this orientation once the recruitment process is completed, before the visa process.

It's one hour orientation, so it doesn't affect the timeline of the process





4

Consular Intermediation

Support to apply for the Temporary work visa

We must consider two aspects; the visa payment for each worker can be either a direct payment or refund it If the worker pays for the visas fee, the process can take 7 or 8 days because the payment voucher needs to be cleared


If the employer pays directly, the process takes around 5 or 6 days

The delivery of approved visas depends on the US Embassy's processing time
