Oppose Inhofe "English-Only" Amendment

Dear Senator:

We, the undersigned organizations, are writing to strongly urge you to oppose the Inhofe "English-only" amendment to the immigration reform bill currently under consideration in the Senate. The Inhofe Amendment, which states English is the national language of the United States, is an overbroad proposal that could restrict the ability of the federal government to communicate effectively with citizens, newcomers, and visitors. In the process, the Inhofe Amendment severely jeopardizes the health and safety of all Americans and impairs national security.

There is no question that English is the common language of this nation; in fact, there is already language in the immigration reform bill which declares that English is "the common language of the United States." Senator Inhofe's amendment is an unnecessary attack on the government's ability to provide effective access to critical information and services.

Recent studies show that the demand for English instruction far exceeds the supply. The real issue is that there is a lack of resources to provide sufficient classes for those seeking to take them. Immigrants want to learn English because they know it is their best path to jobs that will provide greater economic security for their families. This amendment does nothing to address that.

The Inhofe amendment undermines the health and safety of all Americans by undercutting federal, state, and local government's capacity to provide vital information and services to immigrants and Americans who are speakers of other languages. The Amendment could make it more difficult for agencies like FEMA and Centers for Disease Control to respond to a flu pandemic, another Katrina disaster, or another terrorist attack. If some portion of the community does not receive information that it can understand about immunizations or other health threats, the entire public is at risk.

It seeks to undermine an Executive Order, which clarifies the federal government's role in providing meaningful access according to Title VI of the Civil Rights Act prohibiting discrimination based on race and national origin. This Executive Order has been faithfully carried out by President George Bush.

The Inhofe Amendment divides rather than unites our nation. I strongly urge you to vote NO on the Inhofe Amendment. Sincerely,
