Historical National Average Processing Time for All USCIS Offices

The following table shows the national average processing times for select forms based on all USCIS Offices for Fiscal Years 2014 through 2018. A fiscal year runs from October through September of the following year. The data from 2018 runs up to March 31st, 2018 and will update monthly.

These processing times are based on the age of the workload that USCIS has awaiting adjudication (pending cases) and combines data from all of the USCIS offices. The data represents the average of the periodic processing times calculated throughout each fiscal year.
