Dear Attorney General Sessions,

The 465 undersigned faith-based, immigration, civil rights, human rights, worker rights, and antiviolence service and advocacy organizations write to express our profound concern for the lives and safety of immigrant survivors of domestic violence following your wrongful decision in *Matter* of A-B-. We ask that you immediately revoke this legally and factually erroneous decision.

As you know, women like the respondent in *Matter of A-B*- endure horrific violence including sexual assault and other torture in their home countries. Women and girls are frequently unable to escape harm, and are killed by their abusers as a result. Those who undertake and survive the perilous journey to the United States to seek asylum under our laws do so because their home country has not upheld its obligation to protect them. For decades, the U.S. has proudly provided safe haven to vulnerable refugees for this reason as outlined in the United Nations (UN) Convention and Protocol Relating to the Status of Refugees.

Your decision in *Matter of A-B-* is fundamentally flawed both in its legal analysis and as a matter of policy. Consistent with longstanding domestic case law, U.S. Department of Homeland Security (DHS) policies, and current regulations governing asylum as well as international jurisprudence and UN guidance, DHS itself has taken the position consistently since 2004 that women like Ms. A.B. should qualify for asylum. Specifically, the agency agrees that domestic violence may rise to the level of persecution, a cognizable social group centered around gender may be constructed in cases involving domestic violence, and the "state actor" requirement for asylum may be satisfied when a persecutor is an intimate partner. Your efforts to undermine the growing consensus that women fleeing domestic violence may establish asylum eligibility by encouraging adjudicators to pre-judge claims without consideration of the individual facts will potentially result in further tragedy and unspeakable horror for traumatized women, children, and LGBTQ immigrants.

Under U.S. and international law, our country is obligated to provide refuge to individuals who suffer persecution and are unable to avail themselves of protection in their home countries. Your decision in *Matter of A-B-* undermines this nation's adherence to its legal obligations, especially when combined with your "zero tolerance" policy that is resulting in the prosecution of individuals seeking asylum, family detention, and the cruel and inhumane separation of parents (mostly mothers) from their children.

By treating immigrants like criminals, dehumanizing them and their families, and stripping them of the right to live in safety, you are sending a clear message to immigrant survivors of violence: you aren't safe here, either. This reflects a shameful attempt to drag the United States back to an era in which women's rights weren't recognized as human rights, and when women fleeing horrific gender-based persecution were wrongfully denied protection.

Matter of A-B- distorts the will of Congress and seeks to undermine the very meaning and purpose of international protection for refugees. We are privileged to have the power to prevent needless suffering by those fleeing gender-based violence. As a nation, we should be proud to uphold our commitments to those seeking our protection.

## In light of the above, we ask that you immediately revoke your erroneous decision in Matter of A-B-.
