Instructions for *webCLE*

DEADLINE for 2025 AILA Hot Topics and Survival Skills Conference
Tuesday, March 11, 2025!

AILA will be using *webCLE* to track your CLE credits. Below are instructions on how to use *webCLE* to record your credits and obtain your certificate for this conference.

- **Make note!** Be sure to make note of each session you attend throughout the conference. You will need to know the exact sessions you attended when you use *webCLE*.
- **Write down the code!** There will be a **four-digit CLE code announced at each session**. You will need these codes to record your attendance in *webCLE*. We use these codes to comply with the states' requirement that CLE providers be able to verify whether participants attended the entire session for which they claim credit.
- **Log in to *webCLE*!** If you have used *webCLE* before, just log in to your account at www.ailawebcle.org.
 - **Forgot your AILA member number?** Go to AILA InfoNet (www.aila.org) and click on "Forgot Password."
 - **New to *webCLE*?** If you are using *webCLE* for the first time, you will need to register for a free account. Enter your name, contact information, AILA number, jurisdiction(s), and bar number(s). Please be sure to enter all of the states in which you would like to receive credit.
 - **Not an AILA member yet?** All Nonmember Numbers start with the letters NM and are followed by numbers (e.g., NM39748). You can request your Nonmember Number by emailing us at cle@aila.org.
- **Record your attendance!** You can record your attendance by **Tuesday, March 11, 2025**. To report your attendance, visit *webCLE* then click "MyEvents"> "[Conference](#)"> "2025 AILA Hot Topics and Survival Skills Conference."
- **Print your certificate!** Once you have recorded your attendance of this program, you will be able to view your credit summary and print your certificate of attendance at any time from the "MyCredits"> "Conferences" tab.
- **Attention Virginia attorneys!** These jurisdictions require additional forms from attendees.
 - The Virginia forms are specific to the recorded sessions and will be **emailed** directly to all participants in those jurisdictions **once attendance is processed**.
