If you are a lawful permanent resident (LPR) or conditional permanent resident (conditional LPR) of the United States traveling overseas temporarily, you may ordinarily use your Permanent Resident Card or a Reentry Permit, in place of a visa. If you are not in possession of a valid, unexpired Permanent Resident Card or Reentry Permit (for example, your card or permit was lost, stolen, destroyed, or mutilated), you may experience difficulties when you attempt to return to the United States.</p> <p>[new]</p>	<p>[Page1]</p> <p>What Is the Purpose of Form I-131A?</p> <p>United States laws impose penalties on carriers (airlines, ships, etc.) that bring to the United States foreign nationals who are not in possession of a valid passport and any required visa. If you are a lawful permanent resident (LPR) or conditional permanent resident (conditional LPR) of the United States traveling overseas temporarily, you ordinarily may use your valid Permanent Resident Card (commonly called a Green Card) or a Reentry Permit (in place of a visa) as documentation of your eligibility to return to the United States. If you do not have a valid, unexpired Permanent Resident Card or Reentry Permit (for example, your card or permit was lost, stolen, destroyed, or damaged), you may experience difficulties when you attempt to return to the United States.</p> <p>If you are not an LPR or a conditional LPR, but you received a Form I-512/Form I-512L, Advance Parole Document, or Form I-766, Employment Authorization Document (EAD), with travel endorsement, and your document was lost, stolen, destroyed, or damaged while you are traveling overseas temporarily, you also may experience difficulties when you</p>

	<p>This application allows individuals in this situation to apply for a Travel Document (Transportation Letter or Boarding Foil). If the Department of Homeland Security (DHS) determines that the applicant remains an LPR or conditional LPR, DHS may, as a matter of discretion on a case by case basis, provide a Travel Document. The Travel Document may be a foil placed in the applicant's passport or a boarding letter. If DHS provides a Travel Document, the applicant may present the document to the carrier destined for the United States. Generally, a Travel Document is valid for 30 days from the date of issuance.</p> <p>Warnings</p> <ol style="list-style-type: none"> 1. The Carrier Documentation may be a foil placed in your passport or a boarding letter. If DHS provides Carrier Documentation, you may present the documentation to a carrier destined for the United States.
